#### C. Report of the Executive Director

Executive Director, Joe Favaloro, surveyed members to see if they were interested in having a December "Spaghetti Session" to informally discuss topics chosen by the Executive Committee. Mr. Favaloro also noted that there have been positive updates with respect to the staffing issues within the Division of Water Supply Protection. After nearly four years, all vacant positions have been posted.

#### D. Action Item: Advisory Board Mission Statement & Bylaws

Executive Director, Joe Favaloro, noted that there was healthy discussion on the drafted Advisory Board Mission Statement and Bylaws during the October Executive Committee meeting. Staff have incorporated the feedback and edits of members into the drafts as presented today.

Maurice Handel moved for the approval the drafted Advisory Board Mission Statement and Bylaws. David Manugian seconded the motion and it was added to the omnibus roll call vote for the end of the meeting.

#### E. Regionalization Discussion

Executive Director, Joe Favaloro, continued discussion on how the long-standing concept of a regional water system for the greater Boston area could play a pivotal role in confronting the growing PFAS issues facing Commonwealth communities. The presentation included potential available federal and state funding and possible advantages of waiving the entrance fee for incoming communities.

#### F. Operations Committee Meeting Report

Deputy Executive Director, Matthew Romero, gave a brief overview of the recent Operations Committee meeting. The new meters will go into use on January 1, utilizing the MWRA's 3 year averaging methodology. No votes were made during the Operations Committee meeting.
