Environmental Justice (EJ)

- Environmental justice (EJ) is based on the principal that all people have a right to be protected from environmental hazards, and to live in and enjoy a clean and healthful environment regardless of race, color, national origin, income, or English language proficiency.
- Environmental Justice is a priority of the Commonwealth. In September 2020, the EEA Environmental Justice Task Force (under the EEA EJ Policy and EO552) convened a Secretariat-wide task force on EJ.
- To promote environmental justice, members of the environmental justice task force developed EJ strategies tailored to their agencies' mission. A Secretariat EJ Strategy would consolidate the strategies







Promote environmental, energy, and climate justice across the Commonwealth

- MWRA develops first (EJ) strategy
- MWRA incorporates the following EJ principles
 - Expanding public outreach
 - Translating documents
 - Mitigating impacts
- MWRA hired EJ Community liaison
- EEA Secretariat-wide task force for language access forms



In February 2024, Massachusetts unveiled its first EJ Strategy. As part of this Secretariat wide initiative.



As part of our commitment to our member communities, MWRA developed an EJ strategy that aligns with our mission. Further, our EJ strategy includes the following principles that outline MWRA's actions and visions for promoting EJ considerations across MWRA's programs, policies, and activities.

- Communication and Outreach
- Public Engagement and Participation
- Trainings
- Hiring
- Grant and Zero Interest Loan Opportunities
- Environmental and Public Health





Incorporating our principles

MWRA has taken a number of steps in order to implement this strategy. In support of the identified pathways, EJ principals are incorporated into all programs and projects, including but not limited to:

- Compliance with new education and outreach requirements associated with the Massachusetts Environmental Policy Act (MEPA) regulations
- Compliance with Massachusetts' Department of Environmental Protection's (MassDEP's) new Sewage Notification Regulations
- Looking at the associated costs and benefits for each project to our communities (specifically EJ populations)
- Review of all new engineering design and construction projects for their impacts and benefits to surrounding EJ populations
- Looking at the Capital Improvement Plan (CIP) and include a discussion about impacted EJ populations in the CIP



- EEA defines Environmental Justice Populations as neighborhoods that meet one or more of the following criteria (based on Census and American Community Survey data):
 - the annual median household income is not more than 65% of the statewide annual median household income;
 - minorities comprise 40% or more of the population;
 - 25% or more of households lack English language proficiency; or
 - minorities comprise 25% or more of the population and the annual median household income of the municipality in which the neighborhood is located does not exceed 150 percent of the statewide annual median household income.

MASSACHUSETTS WATER RESOURCES AUTHORITY - PUBLIC NOTICE The Massachusetts Water Resources Authority (MWRA), pursuant to its authority under St. 1984, c.372, §§ 6 and 8, as amended, and in accordance with M.G.L. c. 30A, will hold a public hearing on proposed amendments to its Sewer Use Regulations, 360 CMR 10.000. These proposed amendments:

- a) incorporate changes required by the U.S. Environmental Protection Agency ("EPA") to bring MWRA's Sewer Use Regulations in conformance with EPA's Pretreatment regulations;
- b) increase annual charges paid by permit holders; and
- c) clean up minor typos





 - Visitors to www.mwra.com are able to translate all of the web pages








Who funds the private side replacement matters

- A key impediment to LSL replacement is the cost of the private side
- Studies show significant disparity between wealthy and less advantaged households



Environmental Justice areas within metro water service area






Lead Service Line (LSL) prevalence

Based on current data:

- Over 20 communities have some LSL
- Five communities have over 5% LSL
- Several MWRA communities have substantial numbers of LSL
- Will have more complete data after October





Opportunities to do better

- Substantial overlap with EJ areas
- Some communities are prioritizing
 - EJ areas
 - High proportion of children
- New MWRA 25% grant if fully fund private side replacement
- Some other grant opportunities for prioritized efforts
